Letter of Agreement Template for Elective Rotation

- a. Institutional affiliate is not reimbursing UMMC for the rotation (no Attachment C)
- b. Use for any elective rotation when the institutional affiliate is asking for a mutual agreement.
- c. Professional liability for residents and fellows is provided by UMMC

Non-Standard Affiliation Agreement Template With Reimbursement

Non-Standard Affiliation Agreement Template WITHOUT reimbursement

- a. Institutional affiliate is not reimbursing UMMC for the rotation (no Attachment C)
- b. Institutional affiliate is NOT VA, Hopkins, Mercy or a state owned/operated institution.

Johns Hopkins University/Hospital

- a. Institutional affiliate may or may not be reimbursing UMMC for the rotation. If they **are** reimbursing UMMC, you must note this in Exhibit B of the Program Letter of Agreement (PLA) and answer "YES" to Q7. If they are **not** reimbursing UMMC, you would answer "NO".
- b. Residents and fellows are rotating to Johns Hopkins Hospital only.
- c. Professional liability is not detailed in the PLA and requires the Sending Institution to cover the malpractice insurance, so UMMC (Maryland Medicine Comprehensive Insurance Program) would cover the malpractice insurance for UMMC residents and fellows on rotation.

- c. Residents are rotating to Mercy for training in Pediatrics, Emergency Medicine, Dermatology or Anesthesia under the direct supervision of University physicians
- d. Professional liability insurance for residents and fellows is provided by UMMC.

- a. Mercy is NOT reimbursing UMMC for the rotation (no Attachment C)
- b. Institutional affiliate is Mercy Medical Center
- c. Residents are rotating to Mercy for training in Pediatrics, Emergency Medicine, Dermatology or Anesthesia under the direct supervision of University physicians
- d. Professional liability insurance for residents and fellows is provided by UMMC

Mercy Other Affiliation Agreement WITHOUT Reimbursement

- a. Mercy is NOT reimbursing UMMC for the rotation (no Attachment C)
- b. Institutional Affiliate is Mercy Medical Center
- c. Residents are rotating to Mercy for training other than Pediatrics, Emergency Medicine, Dermatology, or Anesthesia and are under the direct supervision of Mercy physicians
- d. Mercy provides Professional Liability insurance for residents and fellows

VA Affiliation Agreement

- a. VA may or may not be reimbursing UMMC for the arrangement. The financial arrangement is not covered in the affiliation PLA, but rather through a separate disbursement agreement between UMMC and the VA.
- b. Institutional Affiliate is VA Medical Center
- c. VA provides professional liability for residents and fellows through Torte Reform Claims Act
